

# SEKISUI UPDATE NO 16

Since we last reported, we have attended another Court Review on 19 July 2019.

All steps in the Court process are proceeding fairly well on time. Provided there are no unforeseen circumstances, a Hearing commencing 18 November in Maroochydore is inevitable. Please mark this date tentatively in your diary.

This Court case is being run by Development Watch Inc as the First Appellant with the Sunshine Coast Environment Council Inc as the Second Appellant. Friends of Yaroomba Inc. have been working hard to fundraise. DW has engaged specialist planning solicitors, four expert witnesses and specialist barristers, the minimum team required for this massive task. With this strong team we believe we will have a good chance of winning this Appeal.

Thanks to the generosity of our supporters, to date our costs have been covered. But the most expensive time in the Court process is the lead-up to the Trial when more than two hundred thousand dollars needs to be provided 'up front'. If we are to have any hope of winning this case, we need continued financial support from the community. If we don't get that financial support, our chances of success will be considerably diminished.
